## STAGE 2 OF THE EMERGENCY DROUGHT PLAN IS IN EFFECT

As ordered by TCEQ effective, **16 May 2022**, Tri-Community Water Supply Corporation must enter into our Emergency drought contingency plan as set and approved by the South Central Texas Regional Planning Group (Region L) and adopted by Tri-Community Water Supply. **STAGE 2** is a **MANDATORY** reduction in daily water demand in order to stabilize water levels and achieve a 20% in total water consumption.

Members may water lawns, plants ect. By means of a soaker hose, hand held hose, individual sprinkler or sprinkler system on the days of the month and times specified for their area of the system. Please report any leaks to TCWS.
